Based on the analyzed cash flows, which can easily be further clarified by the user, the module shows you all the information in the system about suspicious payments, which are probably related to a closed contract.

With a few clicks, these can then be included in a contract overview, which you can also complete manually and which offers you an optimal overview of all your contracts. It is also possible, for example, to put a contract on resubmission, so that you will be informed of its end a few weeks before it expires.



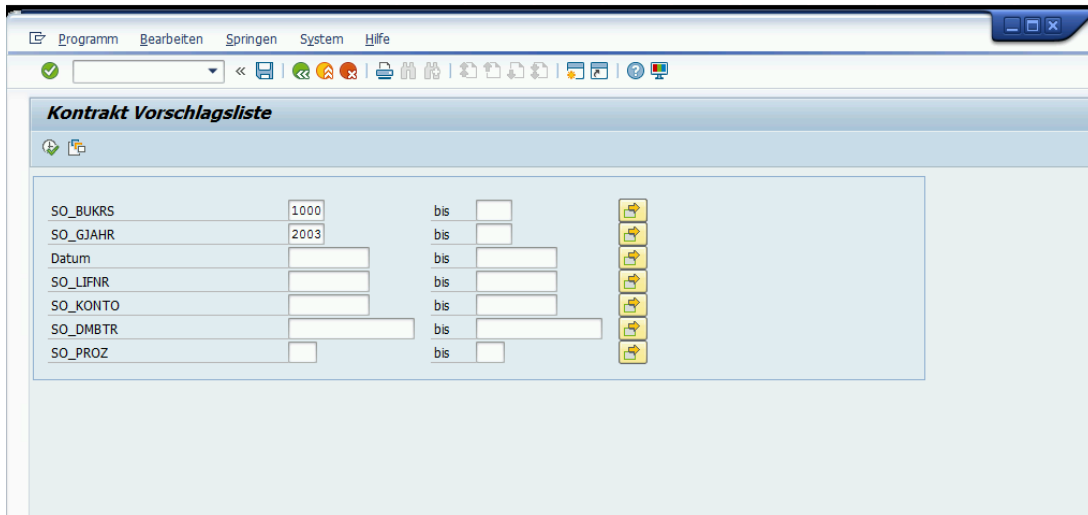
